

Good Neighbor Agreement Addendum No. 1

RECITALS

- A. On December 18, 2015 Intel Corporation (**Intel**), Neighbors for Clean Air (**NCA**), and the Northwest Environmental Defense Center (**NEDC**) (collectively referred to as the **Parties**) entered into a Good Neighbor Agreement (**GNA**).
- B. Consistent with the terms of the GNA, the Parties have regularly participated in meetings of the Air Quality Advisory Committee (**AQAC**).
- C. Paragraph 8.3 of the GNA requires that AQAC meetings be held quarterly.
- D. The Parties recognize that there may be quarters where insufficient information is available to merit holding a meeting.
- E. Paragraph 12.4 of the GNA states that the Agreement may be amended by a written addendum signed by authorized representatives of the Parties.
- F. The Parties desire to amend the GNA to authorize the representatives of the Parties to not convene a quarterly meeting up to one time per semi-annual period subject to the terms and conditions of this Addendum No. 1 (**Addendum**).

TERMS OF ADDENDUM

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the Parties mutually agree as follows:

1. The representatives of the Parties may cancel an AQAC meeting if each of the representatives, in their sole discretion, unanimously conclude that there is insufficient new information to merit holding an AQAC meeting in a particular quarter. The representatives of the Parties shall communicate verbally or electronically at least 4 weeks prior to each scheduled AQAC meeting to determine whether that meeting should be held or be cancelled. If a meeting is cancelled, timely electronic notice shall be provided to all AQAC members and all persons that have provided email addresses for purposes of receiving AQAC notices. In addition, notice shall be posted to the AQAC web page informing the public of the meeting cancellation. Notwithstanding this provision, at least one AQAC meeting shall be held in each semi-annual period (i.e., January - June, July - December).
2. No aspect of the GNA is revised by this Addendum except as specified in Paragraph 1.
3. The individuals executing this Addendum below represent that they are authorized to execute this Addendum on behalf of the respective Party. This Addendum

may be executed simultaneously by all the parties or individually in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same Addendum.

4. This Addendum shall be effective as of the date of the last Party representative to sign below.
